432 Racial and Ethnic Balance Review-- ORC 3314.03

Summary

A governing authority is required to review a breakdown of its student body demographics and compare such with the community it serves.

Compliance Requirements

Ohio law requires community schools to achieve a racial and ethnic balance that reflects the communities served by the school. The governing authority of the school should review the ethnic and racial balance of the school at least once a year and, if applicable, upon any significant increases in enrollment. The review should occur during a board meeting and the following items should be created and reviewed by the governing authority.

- A list of grade and total of the entire student population including ethnic and racial subgroups as well as other applicable subgroups.
- A document that identifies the racial, ethnic and breakdown of other applicable subgroups of the school compared to the communities the school serves.
- Plan for additional targeted marketing if there is significant variance from the school to its surrounding communities.
